MINUTES WFRC || Transportation Coordinating Committee November 20, 2025

WFRC Transportation Coordinating Committee Meeting was held at WFRC Office, 41 N Rio Grande Street, Salt Lake City and via Zoom.

1. Welcome & Consent Agenda [00:00:05]

Commissioner Jim Harvey, Vice Chair, called the meeting to order at 1:30pm and excused Chair Mayor Mark Shepherd. After welcoming committee members and guests, introductions were made around the table for those attending in person, and the names of those attending online were read.

a. ACTION: Minutes of the Trans Com Meeting held August 21, 2026 [00:04:48]

A motion was made by Mayor Joe Smolka, and seconded by UTA Trustee Carlton Christensen, that the minutes of the meeting be approved as presented. The affirmative motion was carried unanimously.

2. Chair Report [00:05:10] Outgoing members of the committee were recognized and **[01:08:30]** invited to say a few words.

3. Public Comment [00:05:43] Commissioner Harvey opened the meeting for public comment. There were no public comments.

4. Transportation Improvement Program (TIP) [00:06:21]

a. Report: Board Modifications to the 2026-2031 TIP [00:07:50]

Commissioner Harvey turned the time to Ben Wuthrich, WFRC, who reported that since the last meeting of Trans Com, WFRC received requests to modify the current 2026-2031 Transportation Improvement Program (TIP). These modifications were approved by the Regional Council at their October meeting but did not require a new air quality conformity analysis or a 30-day public comment period. Mr. Wuthrich referred Committee members to the meeting materials for information regarding these modifications.

b. ACTION: Board Modifications to the 2026-2031 TIP [00:08:30] Mr. Wuthrich continued his report, stating that there were new requests to modify the 2026-2031 Transportation Improvement Program (TIP). These modifications require action from Trans Com and the State Transportation Commission but do not require a new air quality conformity analysis or a 30-day public comment period. Mr. Wuthrich briefly discussed each project. **[00:20:56] ACTION:** Mayor Dirk Burton made a motion to approve the resolution to modify the 2026-2031 TIP as requested, seconded by Mayor Rob Dahle. The affirmative vote was unanimous.

5. Utah Transit Authority and Utah Department of Transportation updates [00:21:50]

a. UTA tentative 2026 budget

The Utah Transit Authority has been preparing their budget for the calendar year 2026, and Commissioner Harvey invited Carlton Christensen, UTA Trustee Chair, to present an overview, which he did.

b. UDOT upcoming funded capacity projects [00:41:09]

Commissioner Harvey then turned the time to UDOT Region 1 Program Manager, Paul Egbert, and UDOT Region 2 Program Manager, Kendall Draney, who shared presentations outlining several of UDOT's upcoming funded project priorities.

6. Other Business and Adjournment [01:10:56]

Commissioner Harvey noted that the next Trans Com meeting will be held on Thursday, February 19, 2026. He then called for a motion to adjourn the meeting. Mayor Joe Smolka motioned that the meeting be adjourned and it was seconded by Mayor Rob Dahle. The meeting ended at 2:42pm.
